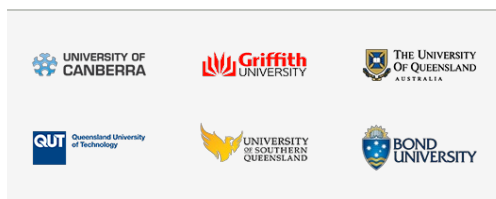
University pathways
